Prof. David Schultz

On Thursday October 8, Prof. David Schultz will discuss Money, the Root of All Political Evil. A renowned speaker, Prof. Schultz teaches at Hamline and the University of Minnesota School of Law. He has written over two dozen books and many articles on democracy, campaign finance reform, and media and politics. He is also a TV political analyst.

On Saturday, October 10 Lonni

Skrentner addresses Money and Corruption in Politics. Lonni is a

member of the LWVUS Study Committee on Money in Politics. She will introduce and then show a video TED talk, We the People and the Republic We Must Reclaim, by Prof. Lawrence Lessig of Harvard Law School. Prof. Lessig introduces the concept of "dependence corruption", the amount of time that lawmakers must spend raising the huge amounts of money necessary in modern campaigns. After the video, the audience will break into small groups to read articles related to campaign finance, and then share with others what they have learned. It's a jigsaw method, of learning more than you have time to read. There will be time for Q and A.

November Unit Meetings Planning for the Future of Edina's Parks

Director Edina Parks and Recreation

The City of Edina is developing a comprehensive Park, Recreation and Trail Strategic Master Plan to guide development and redevelopment over the next 10 to 15 years. On Thursday, November 12 and Saturday, November 14, Edina Parks and Recreation Director Ann Kattreh will explain how well existing resources meet community needs and what is recommended for the future.



In 2014, the City conducted a Community Needs Assessment Study, along with key stakeholder focus group meetings and a public workshop. So far in 2015, a draft has plan been presented to the Park Board and City Council.

Director Kattreh is a native of Wisconsin and a member of both the Wisconsin Basketball Hall of Fame and Track and Field Hall of Fame. She began work with the City of Edina in 1992 and became Parks and Recreation Director in 2012. Everyone is welcome to come and learn more about the Parks Master Plan and what citizens can do to shape the future of Edina's parks.

CMAL Program at Edina Library Saturday Oct. 17, 10:00 – noon

The Council of Metropolitan Area Leagues (CMAL) holds its first meeting for 2015-16 on Saturday Oct. 17 at Edina Library from 10:00 – noon. Refreshments will be served and the meeting is free and open to all.

The program will explain the current process for updating all metropolitan area city/town comprehensive plans. Every ten years, metro area cities and towns must update their comprehensive plans, according to the policy of the Metropolitan Council. Comprehensive plans address such matters as use of land, affordable housing, population, airports, regional parks, sewage management, transportation and water supply.

There will be speakers from both metro cities and the Metropolitan Council. They will address the comprehensive planning process, and how you can get involved. Q and A will follow. We would love to have you join us!

In my mind that is what unlimited money is doing. I am proud of LWV for wading into this "swamp". As individual members I feel we have a responsibility to study up and help our national organization to craft the best position possible - one that will help tackle this issue!



School Board Candidate Forum Held September 10

LWVEdina hosted a candidate forum for the seven candidates running for three seats on the Edina School Board. The forum was moderated by Judy Duffy, who is a member of the White Bear Area League, former President of LWVMN, and former board member of LWVUS.

All candidates were invited and six of them participated in person in the forum. A seventh candidate sent an opening statement which was read by the moderator.

The candidates answered written questions from the audience. There was also a lightning round, in which each candidate was asked a different question and which he/she had to answer in one sentence.

The candidates for school board are: Melanie Allen, Layla Avila, Claudia Carr, Cathy Cella, Amir Gharbi, Leny Wallen-Friedman, and Sarah Patzloff. The school board election is Tuesday November 3.

LWVEdina paid the city to videorecord the entire forum. The video will be available for viewing on our website, lwvedina.org. It will also be replayed on the city of Edina's cable channel 16 through Election Day, on this schedule: Mondays at 10 PM, Tuesdays at 6 AM and 2 PM Thursdays at 7 PM Fridays at 3 AM and 11 AM.
